In attention to the office No. FCICPILLE-Q-EC-SEPTEMBER-2019-OFI-No.-009 of 30 September 2019, entered in this State Portfolio with procedure No. MCYP-DGA-19-2434-EXT of September 30 of the same year, whereby you request the registration of the board of directors of the social organization FULL CORPORACIÓN INVISIBLES CULTURE AND HERITAGE AND LANGUAGE RESEARCH OF LINCHUA DEL ECUADOR, in this regard I would like to express the following:

- 4.- By Ministerial Agreement No. 018 of August 28, 2007, published in the Registry Official No.171 of September 17, 2007, the Organic Management Statute was promulgated Organizational by Processes of the Ministry of Culture, which was reformed by the Ministerial Agreement No. DM-2017-055 of August 09, 2017, which establishes the responsibilities and powers of the General Legal Coordination, within which find the one to carry out: “Registration of the directives, inclusion and exclusion of members of the non-profit civil society organizations ”.
For the foregoing and under the legal considerations stated, once it has been met with the provisions of article 16 of the “Regulation for the Granting of Personality
