Item 1B of the provisional agenda: Election of a chairperson, one or more vice-chairpersons and a rapporteur of the Conference of Parties

Decision required: paragraph 3

1. In accordance with the provisional Rules of Procedure (Rule 4), which are submitted for adoption by the Conference of Parties under item 3 of the provisional agenda, the Conference of Parties shall elect a chairperson, one or more vice-chairpersons and a rapporteur. The Conference of Parties may wish to consider electing a Bureau comprising a total of six members, that is, one member from each of the electoral groups established by the General Conference of UNESCO (see Annex).

2. The term of office of the chairperson, the vice-chairperson(s) and the rapporteur will run from the opening of the current session until the next regular session of the Conference of Parties, when a new Bureau will be elected.
