APPROVAL OF REGULATIONS OF LAW N° 28296, GENERAL LAW OF THE CULTURAL HERITAGE OF THE NATION

EXECUTIVE ORDER N° 011-2006-ED

THE PRESIDENT OF THE REPUBLIC

WHEREAS:

Law N° 28296, General Law of the Cultural Heritage of the Nation establishes national policies for the defense, protection, promotion, ownership, legal regime and the destination of the property part of the Cultural Heritage of the Nation;

Since the Fourth Final Provision of the above-mentioned Law states that the Executive Branch shall regulate this Law; by Ministerial Resolution N° 0424-2004-ED, the Commission in charge of preparing the Regulations of the General Law of the Cultural Heritage of the Nation, which was reconstituted by Ministerial Resolution N° 0703-2005-ED, was constituted;

The above-mentioned Commission carried out its mission and by Official Letter N° 001-06-ME/CRLGPCN, has forwarded the Regulations draft, which consists of 12 Chapters, 96 articles and a Complementary Provision, so it is relevant to proceed with the corresponding approval;

As provided for in paragraph 8) of Article 118th of the Political Constitution of Peru and Legislative Decree N° 560.

IT IS HEREBY ORDERED AND DECREED:

Article 1st.- Approval

To approve the Regulations of Law N° 28296, General Law of the Cultural Heritage of the Nation, which consists of 12 Chapters, 96 articles and a Complementary Provision, which as an annex is part of the this Executive Order.

Article 2nd.- Countersignature

This Executive Order is countersigned by the Minister of Education.
