THE PRESIDENT OF THE REPUBLIC OF PERU

WHEREAS:

The Congress of the Republic has passed the following law:

LAW DECLARING OF NATIONAL INTEREST THE INVENTORY, CADASTRE DEVELOPMENT, RESEARCH, CONSERVATION, PROTECTION AND PROMOTION OF NATIONAL ARCHAEOLOGICAL SITES AND AREAS

Article 1º.- Object of the Law

To declare of public need and national interest the inventory, cadastre development, research, conservation and promotion of pre-Hispanic archeological monuments as defined in Article 2, Executive Decree No. 004-2000-ED.

Article 2º.- Intangibility

Pre-Hispanic archeological monuments included in Article 1 of the Law are declared intangible and inalienable.

Article 3º.- Mandatory Cooperation

To declare mandatory cooperators to fulfill Articles 1 and 2 of this Law:

- a) Ministries directly or indirectly related to or involved with pre-Hispanic archeological monuments;
- b) Peruvian private and public universities having archeology, tourism and engineering departments or schools in each region;
- c) District and provincial municipalities in which jurisdictions pre-Hispanic archeological monument sites are located;
- d) Regional administration councils
- e) National Superintendency of Public Records Office
- f) National Superintendency of Public Property
- g) Peruvian Police Force

Article 4.- Competent Institution

The *Instituto Nacional de Cultura* (National Institute of Culture) is the institution responsible for planning, managing and enforcing the provisions of this Law.

Let the President of the Republic of Peru be notified for him to enact this Law.
